MANAGERS TO COMPLETE THE SCORESHEETS WITH FULL NAMES WRITTEN IN.

Each team is required to provide a person to do bench on their game.

Failure to do so results in a duty fine of \$5 and the loss of one competition point.

Scoresheet must be completed five minutes before the game.

All players must wear matching, properly numbered singlets.

Plain black (or matching) shorts to be worn.

Penalty for incorrect uniform is the loss of five points for every singlet and one point for every pair of shorts that do not match.

Teams need 3 or more players to commence a game.

Teams who fail this requirement must forfeit the game.

Players must play 40% of schedule matches to be eligible to compete in the final series.

Forfeit fines of \$70 apply when a team is unable to play for any reason.

Only players, coach and manager on the bench please.
